- (1) That in the case of transfer from one recruiting unit to another, the transferred GDSs will rank junior in the seniority list of the new unit to all GDS of that unit who exist in the seniority list on the date on which the transfer is ordered.
- (2) That transfer will be at the cost and expenditure of the Gramin Dak Sevak concerned
- (3) That relief of the GDS may be done by the Divisional Heads after confirming that no disciplinary case/vigilance case is pending/contemplated against the GDS and verification formalities viz (Caste, Education and Police Verification report etc.) should have been completed.
- (4) The aforesaid transfer mentioned in Part-I & Part-II will be governed by all the instructions issued by Directorate on the subject from time to time.
- (5) Before joining as BPM Level-I, the official mentioned at serial No. 1 in Part-I should be imparted prescribed training for BPM.
