<sup>2.1</sup> The qualified candidates have been allocated to their respective parent recruiting unit or Administrative Offices in their order of merit vis a vis preference exercised in first set of preferences and category in which selected vis a vis availability of vacancy in respective category (for the purpose of vertical/horizontal reservation).

- 2.2 After allocation of candidates as per preference for Administrative Offices and Parent Unit(s), remaining candidates in the order of merit has been allocated to other recruiting division(s) where there are unfilled vacancies in respective category.
- 3. One candidate namely Shri Dinesh Kumar having Roll No 141006 of Gurgaon Division has been allowed to be appeared as provisional candidate by Divisional Head concerned. The recruiting authority concerned will check his eligibility before issuing appointment. However, if there is any adverse noticed the same may be reported to this office immediately.
- The names of the candidates have been arranged in the order of merit on the basis of marks obtained by them in the said examination. If, however, any mistake in the name/Roll Number/community of the candidate is noticed the same may be corrected and intimated to this office immediately. In cases where more than one candidate has obtained same marks, Divisional Heads are requested to decide their inter-se-seniority at their end as per rules.
- 5. As per rule the vacancies reserved for PH candidates if remain unfilled in case of Direct Recruitment such vacancy shall not be filled and shall be carried forward as a 'backlog reserved vacancy' to the subsequent recruitment year. The vacancies of PH categories of RMS HR Division and RMS D Division have remained unfilled due to non-availability of a suitable person of disability. Hence, the said vacancy will be carried forward as a 'backlog reserved vacancy' to the subsequent recruitment year.
- 6. Before issuance of appointment orders to the selected candidates, all Divisional Heads should match the photograph of the candidate allowed to appear in the examination with the videography clips recorded during examination. SPOs Ambala is requested to supply a copy of CD/DVD of videography and CCTV footage to all divisional head concerned for further necessary action.
- 7. The Divisional Heads before promotion of the official should ensure that no vigilance/disciplinary case is either pending or contemplated against him/her and no punishment like stoppage of increment is current against the official. In case there is any such case the official concerned may not be promoted and the facts be reported to this office immediately.
- 8. The eligibility of the candidates to take the examination has been decided on the basis of the information furnished by the Divisional Heads while forwarding their applications for this examination. Therefore, all the Divisional Heads are requested to check up the eligibility of the candidates before going ahead. If later it is found that any of the selected candidates was not eligible to take the examination under the existing rules or instructions on the subject or for any other reason whatsoever, his/her name will be deleted from the list of successful candidates or list of candidates securing concession as the case may be. The result is also subject to change due to re-totalling and verification of answer books in accordance with the instructions in this regard.
- 9. The selection of the candidate against reserved vacancy has been made as per category mentioned by the candidate in his application form. All Divisional Heads are, therefore, requested to settle the claim of the candidates belonging to SC, OBC, EWS and PH as per instructions on the subject issued by Department from time to time.
- 10. All Divisional Heads are requested to forward the refusals of the candidates to this office so that the next candidate can be allotted accordingly.
